RE: PERMANENT BAR OF SUWILO GENERAL DEALERS LIMITED, HYCROMAX ZAMBIA ENTERPRISES LIMITED AND SAMQUIP LIMITED FROM PARTICIPATING IN PUBLIC PROCUREMENT

In exercise of the powers vested in the Zambia Public Procurement Authority by section 97 of the Public Procurement Act, No.8 of 2020 and regulation 231 of the Public Procurement Regulations, 2022, be advised that the following companies have been permanently debarred from participating in public procurement in Zambia with effect from the date of this Circular for their misconduct relating to submission of bids, collusion and price fixing:

- i. Suwilo General Dealers Limited and its Directors, Suwilanji Rosen Simwanza and Bright Nino Simwanza of **Plot No. 01 Buteko Avenue, Town Centre, Ndola;**
- ii. Hycromax Zambia Enterprises Limited and its Directors, Ackim Lutepu, Kawina Obed Sansala, Ngalama Lukonga and Kawina C. Nyundo of **Plot No. 3B Sheki Sheki Road, Light Industrial Area, Lusaka;** and
- iii. Samquip Limited and its Directors, Samuel Nkhwazi and Mwansa Chilufya of **Shop No. 06 Cosdown Kansenshi Shopping Centre, Ndola.**

You are therefore expected to enforce this debarment by ensuring that you do not:

- (a) award contracts to Suwilo General Dealers Limited, Hycromax Zambia Enterprises Limited and Samquip Limited;
- (b) sell or issue solicitation documents to Suwilo General Dealers Limited, Hycromax Zambia Enterprises Limited and Samquip Limited or in any other way invite bids from these companies; and

(c) enter into any other dealings or communications with Suwilo General Dealers Limited, Hycromax Zambia Enterprises Limited and Samquip Limited except in respect of existing contracts placed prior to this debarment.

This debarment includes any "successor in interest" including any entity which employs, or is associated with any partners, directors or other officers considered as successors in interest.

Please note that the debarment does not in any way limit Suwilo General Dealers Limited, Hycromax Zambia Enterprises Limited and Samquip Limited from performing outstanding contracts that were entered into before the date of this Circular.

All addressees are urged to ensure that the contents of this Circular are implemented and brought to the attention of all staff under their supervision.
