**RE: SUSPENSION OF HAZEL DANIELS INTERNATIONAL LIMITED AND  
AGRISERVE AGRO FROM PARTICIPATING IN PUBLIC PROCUREMENT**

In exercise of the powers vested in the Zambia Public Procurement Authority by section 96 of the Public Procurement Act, No. 8 of 2020 and regulation 239(3)(b) of the Public Procurement Regulations, 2022, be advised that Hazel Daniels International Limited situated at Stand No.8501 Katanga Road Light Industrial Area, P.O. Box 37512, Lusaka and Agriserve Agro situated at Stand No. 2374, Tiyende Pamodzi, Road Showgrounds Lusaka, have been suspended from participating in public procurement in Zambia for a period of one (1) year with effect from the date of this circular for under performance of contractual obligations in the contracts for supply and delivery of forage seed for 2021/2022 planting season MFL/MPC/ORD/01/2021/L1&L3 and MFL/MPC/ORD/ORD/01/2021/L2&L4.

You are therefore expected to enforce this suspension by ensuring that you do not:

- i. award contracts to Hazel Daniels International Limited and Agriserve Agro;
- ii. sell or issue solicitation documents to Hazel Daniels International Limited and Agriserve Agro or in any other way invite bids from the companies; and
- iii. enter into any other dealings or communications with Hazel Daniels International Limited and Agriserve Agro except in respect of existing contracts placed prior to this suspension.

This suspension includes any "successor in interest" including any entity which employs or is associated with any partners, directors or any other officers considered as successors in interest.

The suspension does not in any way limit Hazel Daniels International Limited and Agriserve Agro from performing outstanding contracts that were entered into before the date of this Circular. Procuring Entities shall not enter into any new contracts with Hazel Daniels

International Limited and Agriserve Agro after the date of this Circular and during the period the suspension is in force.

All addressees are urged to ensure that the contents of this circular are implemented and brought to the attention of all staff under their supervision.
