RE: **SUSPENSION OF BEACHCRAFT INVESTMENTS LIMITED FROM PARTICIPATING IN PUBLIC PROCUREMENT**

In exercise of the powers vested by section 95(1) of the Public Procurement Act No. 8 of 2020 and pursuant to regulation 239(3)(b) of Statutory Instrument No. 30 of 2022 (The Public Procurement Regulations, 2022), the Authority wishes advise that Beach Craft Investments Limited situated at Plot No. 1542 Ngwerere Road Chelstone Lusaka, has been suspended from participating in public procurement in Zambia for a period of two (2) years with effect from the date of this Circular for the submission of a forged National Council for Construction Certificate in the tender for the proposed Fit Out of the ZNPF processing Centre at Chitanda House in Kabwe.

You are therefore expected to enforce this suspension by ensuring that you do not:

1. award contracts to Beach Craft Investments Limited;
2. sell or issue solicitation documents to Beach Craft Investments Limited or in any other way invite bids from the company; and
3. enter into any other dealings or communications with Beach Craft Investments Limited except in respect of existing contracts placed prior to this suspension.

This suspension includes any "successor in interest" including any entity which employs, or is associated with any partners, directors or any other officers considered as successors in interest.

The Authority further wishes to advise that the suspension does not in any way limit Beach Craft Investments Limited from performing outstanding contracts that were entered into before the date of this Circular. Procuring entities shall not enter into any new contracts with Beach Craft Investments Limited after the date of this Circular and during the period the suspension is in force.

All addressees are urged to ensure that the contents of this Circular are implemented and brought to the attention of all staff under their supervision.
