### **RE: SUSPENSION OF SMSIZE SOLUTIONS LIMITED FROM PARTICIPATING IN PUBLIC PROCUREMENT**

In exercise of the powers vested in the Zambia Public Procurement Authority by section 96 of the Public Procurement Act, No. 8 of 2020 and regulation 239(3)(b) of the Public Procurement Regulations, 2022, be advised that SMSize Solutions Limited situated at Deloitte Square, Thabo Mbeki Road, Lusaka, has been suspended from participating in public procurement in Zambia for a period of one (01) year with effect from the date of this circular for the submission of falsified National Pension Scheme Authority Compliance and Workers Compensation Employer Certificates in the tender for the supply and delivery of high-powered solar home system - REA/ONB/G/3/2022. You are therefore expected to enforce this suspension by ensuring that you do not:

- i. award contracts to SMSize Solutions Limited;
- ii. sell or issue solicitation documents to SMSize Solutions Limited or in any other way invite bids from the company; and
- iii. enter into any other dealings or communications with SMSize Solutions Limited except in respect of existing contracts placed prior to this suspension.

This suspension includes any "successor in interest" including any entity which employs, or is associated with any partners, directors or any other officers considered as successors in interest.

Please note that the suspension does not in any way limit SMSize Solutions Limited from performing outstanding contracts that were entered into before the date of this Circular. Procuring Entities shall not enter into any new contracts with SMSize Solutions Limited after the date of this Circular and during the period the suspension is in force.

All addressees are urged to ensure that the contents of this circular are implemented and brought to the attention of all staff under their supervision.
