RE: SUSPENSION OF MULTIPLEX CONTRACTORS AND SUPPLIES LIMITED FROM PARTICIPATING IN PUBLIC PROCUREMENT

In exercise of the powers vested in the Zambia Public Procurement Authority by sections 95 (1) of the Public Procurement Act No.8 of 2020, be advised that Multiplex Contractors and Supplies Limited situated at Plot 1014, Zomba Road, London House, 2nd Floor, Light Industrial Area, Kitwe has been suspended from participating in public procurement in Zambia for a period of one (1) year with effect from the date of this circular for submitting a falsified National Pension Scheme Authority (NAPSA) Compliance Certificate in the tender for the provision of external paint works and the renovation of three (3) cottages and a clinic at Mosi-Oa-Tunya House in Livingstone.


You are therefore, expected to enforce this suspension by ensuring that you do not:

- (i) award contracts to Multiplex Contractors and Supplies Limited;
- (ii) sale or issue solicitation documents to Multiplex Contractors and Supplies Limited or any other way invite bids from the company; and
- (iii) enter into any other dealings or communications with Multiplex Contractors and Supplies Limited except in respect of existing contracts placed prior to this suspension.

The suspension includes any "successor in interest" including any entity which employs, or is associated with any partners, directors or other officers considered as successors in interest.

Please note that the suspension does not in any way prevent Multiplex Contractors and Supplies Limited from performing outstanding contracts that were entered into before the date of this Circular. Procuring entities shall not enter into any new contracts with the company after the date of this Circular and during the period the suspension is in force.

All addressees are urged to ensure that the contents of this Circular are brought to the attention of all staff under their supervision.


