RE: SUSPENSION OF HOSSAIN ENTERPRISES LIMITED FROM PARTICIPATING IN PUBLIC PROCUREMENT

In exercise of the powers contained in section 95 of the Public Procurement Act, No. 8 of 2020 and regulation 230 of the Public Procurement Regulations, 2022, be advised that Hossain Enterprises Limited of Plot No. 649, Kalumbila Housing Unit, Off Mwinilunga Road, Kalumbila has been suspended from participating in public procurement in Zambia for a period of two (02) years with effect from the date of this Circular for failure to execute contractual obligations on contracts signed with Mushindamo Town Council for the construction of a bridge and embarkment on the Mulalashi Stream in Kikola Ward under tender No. TCM/CDF/-20AL/10/05/22 and the Construction of culverts and embankments on Kyambulumina and Kafwembe Streams under tender No. TCM/CDF-22AL/01/05/22.

You are therefore expected to enforce this suspension by ensuring that you do not;

1. award contracts to Hossain Enterprises Limited;
2. sell or issue solicitation documents to Hossain Enterprises Limited or in any way invite bids from them; and
3. enter into any other dealings or communications with Hossain Enterprises Limited except in respect of existing contracts placed prior to this suspension.

This suspension includes any "successor in interest" including any entity which employs, or is associated with any partners, directors or other officers considered as successors in interest.

Be advised that the suspension does not in any way limit Hossain Enterprises Limited from performing outstanding contracts that were entered into before the date of this *FC* Circular. Procuring Entities shall not enter into any new contracts with Hossain *FC*

Enterprises Limited after the date of this Circular and during the period the suspension is in force.

All addressees are urged to ensure that the contents of this Circular are implemented and brought to the attention of all staff under their supervision.
