## CIRCULAR NO. 2 of 2019

To: All Controlling Officers and Permanent Secretaries  
All Chief Executives of Parastatal and Statutory Bodies  
All Town Clerks and Council Secretaries of Local Authorities

RE: **SUSPENSION OF PEACE COPS INVESTMENTS, TRY TECH LIMITED, HABITECH LIMITED, GIFDON ENTERPRISES LIMITED AND LONCH PROPERTIES AND GENERAL DEALERS LIMITED**

In exercise of the powers vested in the Zambia Public Procurement Authority by section 65 of the Public Procurement Act, No.12 of 2008 and regulation 167 of the Public Procurement Regulations, 2011, be advised that the following companies have been suspended from participating in public procurement in Zambia for a period of one (1) year with effect from the date of this Circular: -

- (i) Peace Cops Investments, situated at 1410 Senama Road, P.O. Box 11808, Chingola;
- (ii) Try Tech Limited, situated at Esco Building, Luanshya Road, P.O. Box 71890, Ndola;
- (iii) Habitech Limited, situated at Plot F110a/191, Musonda Ngosa Road, P.O. Box 35779, Lusaka;
- (iv) Gifdon Enterprises, situated at Kambendekela House, Dedan Kimathi Road, Lusaka;
- (v) Lonch Properties & General Dealers Limited, situated at Plot No. 20/1, Lumumba Road, After Buseko Market, Before Oddys, P.O. Box 30504, Lusaka.

You are therefore expected to enforce this suspension by ensuring that you do not:

- (a) award contracts to Peace Cops Investments, Try Tech Limited, Habitech Limited, Gifdon Enterprises and Lonch Properties & General Dealers Limited;
- (b) sell or issue solicitation documents to Peace Cops Investments, Try Tech Limited, Habitech Limited, Gifdon Enterprises and Lonch Properties & General Dealers Limited; and
- (c) enter into any other dealings or communications with the five (5) companies except in respect of existing contracts placed prior to this suspension.

This suspension includes any "successor in interest" which employs or is associated with any partner and directors of Peace Cops Investments, Try Tech Limited, Habitech Limited, Gifdon Enterprises Limited and Lonch Properties and General Dealers Limited.

Please note that the suspension does not in any way limit Peace Cops Investments, Try Tech Limited, Habitech Limited, Gifdon Enterprises Limited and Lonch Properties and General Dealers Limited from performing outstanding contracts that were entered into before the date of this Circular. Procuring Entities shall not enter into any new contracts with these companies after the date of this Circular and during the period the suspension remains in force.

All addressees are urged to ensure that the contents of this circular are implemented and brought to the attention of all staff under their supervision.
